COMMON THREADS AWARD INFORMATION

The Common Threads Award honors women with past or present roots in agriculture who have made remarkable and visible contributions to both the agricultural industry and their communities. Each year, recipients are selected from the nominations submitted, recognizing women who have made a lasting impact through their careers, service, time, talent, or treasure.

Submission Details

Completed nomination packets must be received by the California Agricultural Leadership Foundation (CALF) no later than midnight on **Tuesday, December 1, 2026**. Submissions may be sent electronically or by standard mail.

2027 Award Criteria

- Nominees must have roots and have made a significant contribution in one of the following counties: Fresno, Kern, Kings, Madera, Merced, or Tulare.
- Nominees must have past and/or present connections to agriculture and demonstrate outstanding involvement in both the agricultural industry and their community. This may include meaningful contributions through philanthropic giving, volunteer service, or other impactful support.
- Nominations must be submitted by someone who personally knows the nominee. *Self-nominations will not be accepted.*

Important Notes

- Please do not inform your nominee of the submission.
- The Common Threads Selection Committee will notify nominators and honorees of final decisions by December 14, 2026.
- If a nominee is not selected this year, her application will remain active and eligible for consideration for the following two years.

All nomination packets must include the following to be considered:

- ☐ Letter of introduction
- ☐ Nomination form & responses to questions
- ☐ Color photo of the nominee

Optional: Up to three letters of recommendation may be included, though they are not required for consideration. If submitted, recommendation letters should come from individuals with a personal and direct understanding of the nominee's qualifications, rather than from casual acquaintances.
